

A municipality can earn 10 points for supporting an active community garden in which all members of the community can participate. Additional points can be earned if the garden policies require all members to practice environmentally friendly gardening practices (5 points) and garden leadership coordinates efforts to donate some of the garden produce to local food pantries or other food distribution efforts.

The submission questionnaire is broken into three sections reflective of these options. At a minimum, completion of the community garden section is required and this form must be uploaded to your action submission.

Reminder: The garden **must be operational in the year the municipality is applying for certification.** For example, if a municipality is applying for certification in 2020, but only provides information about the garden in 2019, it will not qualify. This action is specifically for a community garden. A school garden will only be eligible for points if the municipality demonstrates meaningful support and ongoing involvement in the garden as outlined in the <u>action description</u>.

II. ENVIRONMENTALLY FRIENDLY GARDENING (5 POINTS)

Please describe the community gardens environmentally friendly gardening policies.	We are an organic garden, we do not use any chemicals for pest control. We utilize companion planting and vegetation/ flowers to promote a healthy ecosystem, pollination and pest control. Organic compounds are used if and when stronger methods are needed, like vinegar, neem, Castile soap etc. we look for natural ways. We compost vegetable scraps to build nutrient dense soil, and have used cow manure from a cow sanctuary and mushroom compost from a farm to boost soil quality. We chop and drop in each garden bed at the end of each season to compost vegetation. Our gardening policy is also about the community, to provide a friendly open garden green space to enjoy and reboot. Sitting in nature is soothing and revitalizing and distressing.


III. PRODUCE DONATION (5 POINTS)
