Tom: IT manages the Code Red system (which is the system we use daily to reach our population with the COVID-19 updates.) The Office of Emergency Management (Pat Kenny) and IT (to some extent) manage the Vulnerable Population database. We maintain links on the web page for residents to sign-up for both systems. The Vulnerable Population database is only utilized during an extreme emergency when we have evacuations due to weather and/or power outages. Usually it occurs when the Governor has declared a State of Emergency and the WCC has been activated as a Evacuation Center.
