RESOLUTION REAFFIRMING THE COMMITMENT AND OBJECTIVE OF THE JERSEY CITY GREEN TEAM.

COUNCIL offered and moved adoption of the following resolution:

Whereas, the City of Jersey City adopted Resolution No. 14.105, “Amendment to Article 345-10 Environmental Commission” which appointed the Environmental Commission as the Jersey City Green Team at a regular meeting conducted on September 10, 2014; and

Whereas, the City of Jersey City resolved in that resolution that it wished to pursue local initiatives and actions that would lead to Sustainable Jersey Municipal Certification; and

Whereas, the City of Jersey City further resolved in that resolution to create the City of Jersey City Green Team, to serve as the City of Jersey City’s agents for the Sustainable Jersey municipal certification process; and

Whereas, the Green Team was composed of individuals who are interested in advancing the efforts of City of Jersey City in the Sustainable Jersey municipal; and

Whereas, that group, has been creating and cataloging significant sustainability actions so that City of Jersey City may achieve Sustainable Jersey certification at the Silver Level in 2021.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JERSEY CITY AS FOLLOWS:

1. The Green Team of the City of Jersey City is active in the community and advancing sustainable practices and actions included in the Sustainable Jersey municipal certification program;
2. The Green Team has been and shall continue to be composed of individuals who have demonstrated interest in advancing the efforts of the City of Jersey City to pursue certification through the Sustainable Jersey municipal certification program; and
3. The role of the Green Team has been and shall continue to be to lead and coordinate the sustainability activities of the community.
