Resolution of the Township of Howell Monmouth County, New Jersey

TITLE: RESOLUTION ESTABLISHING A MUNICIPAL GREEN TEAM

--- RESOLUTION ---

WHEREAS, the Howell Township Council strive to save tax dollars, assure clean air and water; improve the quality of life and build a community that is sustainable economically, environmentally, and socially; a community which would thrive well into the future; and

WHEREAS, the Howell Township Council desires to build a model government which benefits our residents now and far into the future with green community initiatives which are easy to replicate and affordable to implement: and

WHEREAS, in an attempt to focus attention on "Green" issues, the Township Council wishes to establish a Green Team; and

WHEREAS, the Howell Township Council would like to begin the process of focusing on "Green" issues by starting with audits of municipal facilities and operations first.

NOW, THEREFORE, BE IT RESOLVED that the Township of Howell Mayor and Council hereby establishes a Green Team consisting of the following members who shall be residents or employees of Howell Township, appointed annually, but whose initial term of appointment shall be through December 31, 2010.
