RE: Public Electric Vehicle Charging Infrastructure

To Whom It May Concern:

Woodbridge Township is pleased to report the implementation of public Electric Vehicle (EV) charging infrastructure. The two new charging stations are located at 364 Eleanor Place (1 Dual Port Level 2 Charging Station), and 87 New Street (2 Dual Port Level 2 Charging Stations). Through the planning elements of the NJTPA AFV plan, the Township sought grant funding (NJ DEP It Pays to Plug In) for public electric vehicle charging infrastructure, and in February 2022 and March 2022 executed the installation of the aforementioned dual port level two electric vehicle charging stations by working within the confines of said grant program. The charging station locations are listed on publicly accessible directories and can be found directly on the Township's Greenable Woodbridge webpage: https://www.twp.woodbridge.nj.us/7 48/Electric-Vehicle-Charging-Infrastructure. Additionally, the charging station locations are listed on AFDC (https://afdc.energy.gov/stations/#/find/nearest) as well as on Chargepoint's mapping portal (https://na.chargepoint.com/charge point). Furthermore, signage was installed at each location which was designed to depict each EV charging parking space, and it was fabricated on 12"x 18" retro-reflective metal material in order to ensure safety. Promotional materials focused on informing the public included the Township Recycling calendar, Mayor's Facebook page, Mayor's Township Announcements (code red call initially started to inform public about covid-19 and now remains in place for covid important updates), Township website, and Township closed circuit TV 35. Wayfinding signage is under design, and will aid access to the new charging locations.



Be on the lookout....

Zero emission electric vehicles (trucks & shuttle buses) are making their way into Woodbridge!

A grant from the NJDEP for \$2,491,880 allowed Woodbridge to purchase 3 electric garbage trucks and 2 electric shuttle buses. These zero emission vehicles will be a clean and welcome addition to the fleet.

The Downtown Electric Shuttle.....

Two electric shuttle buses will be part of this proposed project. These shuttles will be used in an 18 mile loop that will connect redevelopment sites with transit sites in MetroPark and Woodbridge.

If you have an electric vehicle....

Look for our 3 new charging stations in downtown Woodbridge. One will be on Eleanor St and two will be in the New St parking Lot.
